National Honor Society Chapter Bylaws

Article I: Name and Purpose

Section 1: The name of the chapter shall be the Salina High School South Chapter of the National Honor Society.

Section 2: The purpose of this chapter shall be to create an enthusiasm for scholarship, to stimulate a desire to render service, to promote worthy leadership, and to encourage the development of character in students at Salina High School South.

Article II: Membership

Section 1: Membership in this chapter shall be known as active, honorary, and graduate. Active members become graduate members at graduation. Graduate and honorary members have no voice or vote in chapter affairs.

Section 2: Membership in this chapter is an honor bestowed upon deserving students by the faculty; membership is based on the criteria of scholarship, service, leadership, and character.

Section 3: Eligibility

- a. Candidates eligible for election to this chapter must be members of the junior or senior class.
- b. To be eligible for selection to membership in this chapter, the candidate must have been in attendance for a period of one full semester at Salina High School South.
- c. Candidates eligible for selection to the chapter shall have a minimum cumulative GPA of 3.75 on a 4.0 scale. This scholastic level of achievement shall remain fixed, and be the required minimum level scholastic achievement for admission to candidacy. All students who can rise in scholarship to or above such standard may be admitted to candidacy for selection to membership.
- d. Upon meeting the grade level, attendance, and GPA standard requirements, candidates shall then be considered based on their service, leadership, and character.

Article III: Selection of Members

Section 1: The selection of members to this chapter shall be by a majority vote of the Faculty Council consisting of five faculty members appointed by the principal. The chapter adviser shall be the sixth, nonvoting, ex officio member of the Faculty Council.

Section 2: Prior to selection, the following shall occur:

- a. Students' academic records shall be reviewed to determine scholastic eligibility.
- b. Students who are eligible scholastically ("candidates") shall be notified and asked to complete and submit the Student Activity Information Form for further consideration for selection.
- c. The faculty shall be requested to evaluate candidates determined to be scholastically eligible using the official evaluation form provided by the chapter adviser.
- d. The Faculty Council shall review the Student Activity Information Form and faculty evaluations of each candidate in order to determine membership. Evidence of students'

character, citizenship, and leadership will be evaluated to determine qualifications for membership.

Section 3: The selection of new active members shall be held once a year during the second semester of the school year.

Section 4: Candidates become members when inducted at a special ceremony.

Section 5: Once selected and inducted, all members are expected to maintain all obligations of membership.

Section 6: An active member of the National Honor Society who transfers from this school will be given a letter indicating the status of his or her membership which is signed by both the principal and the chapter adviser.

Section 7: An active member of the National Honor Society who transfers to this school will be automatically accepted for membership in this chapter. The Faculty Council shall grant to the transferring member one semester to attain the membership requirements, and thereafter, this member must maintain those requirements for this chapter in order to retain his or her membership.

Article IV: Discipline and Dismissal

Section 1: Any member who falls below the standards of scholarship, leadership, character, or service may be considered for dismissal from the Salina High School South Chapter of the National Honor Society. A member of the National Honor Society is expected to maintain his or her academic standing and to take an active role in service and leadership to his or her school and community.

Section 2: If a member's cumulative GPA falls below the standard in effect when he or she was selected, he or she will be given a written warning and a time period for improvement. If the cumulative GPA remains below standard at the end of the given time period, the student may be subject to further disciplinary action by the Faculty Council; this action may include consideration of dismissal from the chapter.

Section 3: If a member fails to perform any of the published obligations of membership, he or she will be given a written warning and a time period for improvement. If the obligation remains unmet at the end of the warning period, the student will be subject to further disciplinary action by the Faculty Council, which may include dismissal from the chapter.

Section 4: Violation of the law or school regulations can result in dismissal of a member. These violations include, but are not limited to DWI; MIC; stealing; destruction of property; cheating or plagiarism; truancy; possession, selling, or being under the influence of drugs or alcohol at school or school-related activities.

Section 5: Offenders of the school conduct code (such as using profanity, failure to comply, unexcused absence, excessive tardiness, et cetera) will receive written warning notification. A conference may be requested by either party (Faculty Council, parent, or student). If the member is involved in another violation of the school conduct code, the member may be considered for dismissal.

Section 6: In all cases of pending dismissal:

a. The member will receive written notification indicating the reason for possible dismissal from the adviser or Faculty Council. The member and adviser will discuss the written notification in a conference. Situations that involve flagrant violations of school rules or the law can warrant disciplinary action without a written warning although a hearing must still be held (see below).

b. The member will be given the opportunity to respond to the charge against him or her at a hearing before the Faculty Council prior to the vote on dismissal. The Faculty Council will then vote on whether to dismiss. A majority vote of the Faculty council is needed to dismiss any member.

- c. The results of the Faculty Council vote will be reviewed by the principal and then, if confirmed, expressed in a letter sent to the student, parents, and principal. Dismissed members must surrender any membership emblems or pins to the adviser.
- d. The Faculty Council's decision may be appealed to the building principal and afterwards through the school district discipline policy.
- e. When a student is dismissed or resigns, he or she is no longer a member and may not be reconsidered for membership in the National Honor Society.

Section 7: In lieu of dismissal, the Faculty Council may impose disciplinary sanctions upon a member as they deem appropriate.

Article V: Officers

Section 1: The officers of this chapter shall be president, vice president, secretary/public relations officer, treasurer, and parliamentarian.

Section 2: Student officers shall be elected at the first meeting of the school year. All returning active members are eligible to run for a position as an officer. All active members of the chapter are eligible to vote.

Section 3: A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.

Section 4: It shall be the duty of the president to preside at the meetings for this chapter.

Section 5: The vice president shall preside in the absence of the president and shall also keep a record of members' attendance and contributions to leadership and service. In the event that the president cannot fulfill his duties, the vice president will step up to the position of president and the faculty adviser will select a new vice president.

Section 6: The secretary/public relations officer shall distribute meeting agendas, keep and distribute the minutes of meetings, shall be responsible for all official chapter correspondence, and shall create press releases about chapter activities for publication in various media.

Section 7: The treasurer shall keep the record of chapter expenses, dues, and all other financial transactions of the chapter.

Section 8: The parliamentarian shall be responsible for maintaining and instructing the chapter in proper parliamentary procedure for all meetings.

Section 9: In the event that an officer cannot fulfill his or her duties through the course of a school year, the chapter adviser will select an appropriate replacement.

Section 10: In the event that no one runs for a given office, the elected officers may appoint a member who ran for a different office and placed second.

Article VI: Executive Committee

Section 1: The executive committee shall consist of the faculty adviser and the chapter officers.

Section 2: The executive committee shall have general charge of the meetings and the business of the chapter, but any action by the executive committee is subject to the review of the chapter members and chapter adviser.

Article VII: Meetings

Section 1: Meetings of this chapter shall be held regularly during ELO period. Sometimes it may be necessary to hold meetings before or after school; when this happens, members will have at least two weeks' notice of said meetings.

Section 2: This chapter shall conduct its meetings according to *Robert's Rules of Order*.

Section 3: All chapter members are expected to attend all regularly scheduled meetings. Members who

will be unable to attend a regularly scheduled meeting must contact the chapter adviser and the vice president in advance with their reasons for nonattendance.

Article VIII: Activities

Section 1: The chapter shall determine one or more service projects for each year.

Section 2: All members shall regularly participate in service projects. Members are expected to participate in a minimum of two chapter projects OR to submit a minimum of ten NHS volunteer hours in addition to those submitted for pathway completion. NHS volunteer hours must be submitted to the chapter vice president and adviser before May 1st if the member intends to wear the NHS honor stole at graduation.

Section 3: These projects shall have the following characteristics: fulfill a need within the school or community; have the support of the administration and the faculty; be appropriate and educationally defensible; and be well planned, organized, and executed.

Section 4: Each member may choose to participate in an individual service project that reflects his or her particular talents and interests as approved by the chapter adviser. This option may be selected in place of participation in NHS club service projects.

Section 5: The chapter shall publicize its projects in a positive manner. This will be the responsibility of the secretary/public relations officer.

Article IX: Emblem

Section 1: Each member of this chapter who is in good standing with regard to the membership standards and member obligations shall have the privilege of wearing the emblem (pin) adopted by the National Honor Society.

Section 2: Any member who withdraws, resigns, or is dismissed from the chapter shall return the emblem to the chapter adviser.

Section 3: Chapter members who are seniors in good standing shall be granted the privilege of purchasing and wearing the National Honor Society stole adopted by this chapter at graduation.

Article X: Dues and Other Expenses

Section 1: Dues for this chapter shall be a one-time payment of \$25.

Section 2: Dues will be payable to the chapter treasurer within 30 days of induction.

Section 3: Seniors will purchase their own National Honor Society stoles for graduation. If the chapter officers deem it feasible, they may choose to use club funds to pay for a portion of graduation stoles for seniors.

Article XI: Powers

Section 1: The chapter adviser is given the authority to supervise the administration of chapter activities, as delegated by the school principal.

Section 2: The principal shall reserve the right to approve all activities and decisions of the chapter.

Section 3: These bylaws are designed to amplify provisions of the national constitution and cannot contradict any components thereof. The chapter is obligated to adhere to the provisions of the national constitution in all activities it undertakes.

Article XII: Amendments

Section 1: These bylaws may be amended by majority vote of the chapter, provided notice of the proposed amendment has been given to members at least one month prior to the vote and quorum of

membership exists at the meeting where voting takes place. The exceptions are Articles III and IV (selection and discipline), which are developed by the Faculty Council with the approval of the principal.

Section 2: Bylaws and amendments must be consistent with the constitution of the National Honor Society.
